* Each endorsement should include the current date, flight instructor's name, instructor number, and instructor expiration date. The instructor should maintain a record of each endorsement for a minimum of three years per FAR 61.189(b). *Endorsements may be altered to address individual circumstance as needed.

Flight Instructor Endorsement Guide

An instructor (not necessarily the same instructor) must make an endorsement specific to the make and model of aircraft to be flown. The endorsement does not expire, but the student must have a current solo flight endorsement. #10 - Solo cross-country flight: 14 CFR 61.93(c)(3)
