plural) and gender. For purposes of clarity, try to keep a pronoun relatively close to its antecedent. When the antecedent is not immediately clear, make a change such as rearranging the words, changing from singular to plural, or replacing the pronoun with a noun.

pronoun is not always
known or stated.

EXAMPLES Sam and she were invited, but he couldn't attend. [The pronoun he takes the place of Sam, so Sam is the antecedent.] Sam and she were invited, but he couldn't attend. [The female that the pronoun she takes the place of hasn't been named in this sentence, so the antecedent is unknown.]
